7. Description

Condition

Magruder Law Office is located at 14708 Main Street in Upper Marlboro, Maryland. The one-story, three-bay building was built c. 1860. The building is sited on the north side of Main Street, east of the intersection between Elm Street and Water Street. The building is located in the downtown area of Upper Marlboro, which is primarily commercial. A concrete sidewalk is located between the building and Main Street. Immature trees and shrubs are located to the south of the building in a brick planting box.

LAW OFFICE

Magruder Law Office was constructed c. 1860.¹ The one-story, three-bay Greek Revival-style building has a rectangular form. Set on a solid concrete foundation, this wood-frame building is covered in weatherboard siding. Set between each opening, as well as at the corners of the façade, are engaged Tuscan wood pilasters. The front-gabled roof is covered in asphalt shingles. The tympanum has prominent cornice returns and overhanging eaves. The entablature features dentil moldings and an ogee-molded cornice with modillions. The delicate dentil work extends across the façade while the modillions are present only on the cornice returns and along the side (east, west) elevations. The gable end of the façade (south elevation) is covered in weatherboard siding and features a centrally located arched louvered vent with cavetto surround. Fenestration consists of 1/1 windows with square-edged wood surrounds. Plain rectangular square-edged wood spandrels are located below each window opening. Circular cut-outs are set in the middle of plain rectangular panels above each opening. The entrance is located in the east bay and consists of an inset single-leaf, paneled wood door with lights. A rectangular-light transom with square-edged surround rests above the door. The inset is complimented by plain panels.

A small alley is located along the west elevation of the building. This alley is entered through a modern singleleaf paneled wood door and was not accessible during the 2007 on-site survey.

The west (side) elevation is not symmetrical. The engaged pilasters found on the façade (south elevation) repeat once more along the west (side) elevation. The window opening between the southwest corner pilaster and the single pilaster on the west (side) elevation was boarded up with plywood at the time of the on-site survey in 2007. The remaining bays of the west (side) elevation are clad in weatherboarding.

The east (side) elevation abuts Marcello's Grill at 14710 Main Street. The overhanging eaves of Magruder Law Office extend over this adjacent building.

The interior of the Magruder Law Office was not accessible at the time of the 2007 on-site survey.

INTEGRITY

The Magruder Law Office retains a high level of integrity. The building, based on its form and style, maintains its integrity of design. The building's integrity of materials and workmanship are retained due to the retention of key architectural elements, such as the exterior cladding. Magruder Law Office has functioned as a law office in downtown Upper Marlboro since its construction, retaining its integrity of feeling, setting, association, and location.

STATEMENT OF SIGNIFICANCE

The Magruder Law Office was constructed c. 1860 at 14708 Main Street in Upper Marlboro, Maryland. The building is an example of the Greek Revival-style architecture that was popular in Prince George's County in the mid-nineteenth century. This building is one of the few examples of the style remaining in the county.² The building started as a law office and still served this function at the time of the 2007 on-site survey. The Magruder Law Office retains sufficient integrity to convey its significance as an unusual example of mid-nineteenth-century Greek Revival-style architecture in Prince George's County.

HISTORIC CONTEXT

The Magruder Law Office is located in downtown Upper Marlboro, Maryland. Located in central Prince George's County, the Town of Upper Marlboro was established when the General Assembly of the Province of Maryland passed the "Act for the Advancement of Trade and Erecting Ports and Towns" in 1706 and 1707 in order to establish commercial centers in Maryland.³ Chosen for its location on the Western Branch of the Patuxent River, the area was thought to be a convenient trading location. With its designation as the county seat, Upper Marlboro soon became the social, political, and commercial center of Prince George's County.

As the Patuxent River and the Western Branch silted, the river became unnavigable for large ships transporting tobacco. As a result, Baltimore became the commercial hub of tobacco in Maryland. Even without the tobacco industry, the thriving commercial and political center of Upper Marlboro supported the local economy in the nineteenth century. Martenet's Map of 1861 shows a well-developed small town, mostly centered on Main Street. Most of the residential buildings are located to the west, while the commercial development was primarily located in the east and centered around the courthouse. Upper Marlboro provided a number of shops

and amenities for its residents and visitors. The town was served by several hotels, multiple law offices, and other stores that included a barber shop, carriage factory, tailor, cabinet maker, tinner, doctor's office, and the offices of the *Planter's Advocate* and the *Marlboro Gazette*. By 1861, at least three churches were constructed within the town for the Catholic, Methodist, and Episcopalian congregations. Just a few years later in 1878, the Hopkins map documents considerable new growth in the town. Many new residences and stores were constructed, along with two new public schools, one for the education of boys, and one for girls.

Started in 1823, the law practice of Caleb Clarke Magruder, Sr. prompted the construction of the law office circa 1860. Caleb Clarke Magruder, Sr., born approximately 1810, is listed as an attorney-at-law at the time of the 1850 U.S. Federal Census and married to Mary Sprigg Belt. The couple had three children: Mary, Caleb, and Edward.⁴ Magruder was also a slave owner at the time of the 1850 Slave Schedule. Magruder owned 18 slaves ranging in age from infancy to 34 years of age.⁵

Caleb Clarke Magruder, Jr. joined his father's law practice in 1864. Magruder's grandsons Caleb Clarke Magruder III and Mercer Hampton Magruder joined the family's practice in 1888 and 1889.⁶ These men were considered to be among the most prominent attorneys in Maryland, each in his time acting as lead counsel in many important cases.⁷

Caleb Clarke Magruder, Jr. received the property from his father, Caleb Clarke Magruder, Sr. c. 1870.⁸ In 1906, the building was transferred again within the Magruder family, being conveyed to Mercer Hampton Magruder, Sr.⁹ At the time of the 1930 U.S. Federal Census, Mercer Hampton Magruder, Sr. is listed as living in Prince George's County and working as a general practice lawyer. Magruder and his wife, Mittie Hall Magruder, have three children at the time of the 1930 census: Mercer Hampton Magruder, Jr., Florence H. Magruder, and Mary B. Magruder.¹⁰ The couple has another son in 1933, Alexander Clarke Magruder, Jr.¹¹

Joseph C. Sauerwein obtained the property in 1986 from A. Clarke Magruder, Jr.¹² Sauerwein is a practicing attorney in the state of Maryland, continuing the functional history of The Magruder Law Office.
