d) <u>Presentation: Recommendation to Approve an Employer Contribution in the Amount of \$27,191,305 for Fiscal Year 2016</u> (A. Rose, Employees' Retirement System Administrator; Dave Boomershine, President and Senior Consulting Actuary; and Greg Stump, Vice-President and Senior Actuary)

Employees' Retirement System (ERS) Administrator Andrea Rose shared that each year an independent actuarial valuation is performed to determine the funding requirements for the ERS in order to ensure sufficient assets are available for future benefits. The actuarial valuation is designed to measure the current and future cost of retiree benefits based on employee demographics, assets and liabilities, plan provisions, and actuarial assumptions and methods. Ms. Rose shared that the ERS actuary, Boomershine Consulting Group, presented its completed valuation report to the Employees' Retirement System (ERS) Board of Trustees on November 4, 2014. The ERS Board of Trustees recommends the Commission approve the actuary's determined employer contribution in the amount of \$27,191,305 (20.14% of the covered payroll) for FY16, which is lower than the FY15 contribution. In order to meet the ERS funding objectives, the recommended employer contribution of \$27,191,305 will be made on July 1, 2015, for FY16. The recommended employer contribution decreased slightly from \$28,149,976 (21.8% of covered payroll) as of July 1, 2013, primarily due to a gain in the actuarial asset value.

The PowerPoint presentation on the valuation was made by Boomershine Consulting Group President/Senior Consulting Actuary Dave Boomershine, and Vice President/Senior Actuary Greg Stump to explain the recommendation.

Boomershine Consulting Group (Actuary) reported that the ERS' funding objective is to meet long-term benefit promises through employee and employer contributions. The July 1, 2014 actuarial valuation indicated the funded ratio of the actuarial value of assets to the actuarial accrued liability for benefits was 87.2%, which is up from 83.1% in 2013. This reflects a greater funding of liability.

The Actuary explained the Baseline Contribution Projection graph on page 157 of the packet which assumes a 7.3% return on future investments. Executive Director Barney commented that in looking at a similar graph for the 2008/2009 timeframes, the outcome was not as favorable. She wanted to ensure that everyone understood that the rate of return on investments is not guaranteed as it will shift when the market drops or changes, and contributions may therefore be much higher than projected.

Vice-Chair Anderson asked if the Actuary has begun to look at adjusting the assumed investment return. Mr. Stump responded that the gradual reduction that the Commission has adopted is the correct way to make the adjustment. The amount was reduced by the Board of Trustees from 7.5% to 7.4% last year and to 7.3% this year.

In response to Commissioner Dreyfuss' question about the source of the contributions reported in the presentation, Mr. Stump clarified that the contributions listed in the report reflect employer contributions. Commissioner Dreyfuss inquired about the trend related to the percentage of the annual operating budget that is attributable to the employer contribution. Mr. Stump and Mr. Boomershine responded that there was a reduction in employer contributions. The dollar amounts associated with the contributions were listed in the Total Employer Cost column on page 155 of the packet. The report did not indicate the percentage of the budget.

Executive Director Barney explained that the employer contribution as a percentage of the total budget has been declining. She stated that several years ago, the contribution was between \$32 million and \$34 million. The agency's employer contribution is now \$27,191,305. She shared that additional details can be provided to the Commissioners if desired. She also stated the numbers contained in the report reflect retirement statistics and that the Other Post Employment Benefit (OPEB) presentation will be made next month.

Executive Director Barney mentioned that the lower contributions are in part, related to the Commission adopting a number of recommended changes to the pension program, some of which included greater employee sharing of contributions, 5 year averaging for benefit calculations, and changes in vesting. Changes affecting collective bargaining members were negotiated with the

Unions. As a result, M-NCPPC reduced costs while providing a reasonable benefit so employees can afford to retire.

Commissioner Dreyfuss inquired whether the Actuary is seeing public employers moving to defined contribution plans versus a defined benefit plan. Mr. Boomershine responded that there are very few public employers that have moved to a defined contribution plan design. He shared that defined contribution plans are more common in the private sector because of the changes in federal law, changes in accounting, and a significant amount of artificial intervention.

The Actuary shared that there have been a number of changes in governmental accounting standards for pensions, and changes are also expected in healthcare. The Actuary briefly reviewed some changes that are in process (contained on pages 158 and 159 of the Commission packet). Commissioner Geraldo suggested a footnote be added to the report to explain the funding ratio for GASB.

Executive Director Barney thanked the Employees' Retirement System (ERS) Board for recommending the contribution. She thanked the Commissioners as plan sponsors for the funding and authorizing decisions for the pension program. The ERS staff was commended for their work.

General Counsel Gardner shared a similar bill was proposed last year. M-NCPPC supported the bill in the prior legislative session and it is recommended that the agency support the bill again this year. General Counsel Gardner stated that the operating departments have no concern with implementation of the

bill, and M-NCPPC Park Rules and Regulations will be revised in the near future.

Montgomery County Delegation and Prince George's County Delegation Bill MC/PG 105-15 (Maryland-National Capital Park and Planning Commission – Montgomery County – Commission Terms General Counsel Gardner requested a favorable position on Bill MC/PG 105-15 that was requested by the Montgomery County Council. A legal disagreement exists between Commission lawyers and the Council's lawyers over how to interpret the current law. The language in the bill may change; however, the concept of the bill is that the Montgomery County government should be allowed to have a Planning Board Chairperson who can serve two full terms -- even after serving some time as a member of the Commission (but not as Chair). As the law is currently interpreted by the County, it penalizes a member of the Commission who later becomes the Planning Board Chair. Chair Hewlett recommended this bill be monitored to ensure the language does not change during the legislative process.

On a separate matter, Chair Hewlett congratulated General Counsel Gardner for his outstanding argument on the Farm Road Case presented to the Court of Appeals.

### ITEM 3 <u>DISCUSSION/REPORTS/PRESENTATIONS</u>

a) MARKETING/BRANDING BRIEFING – FOCUS GROUP FINDINGS (LMD Consultants and M-NCPPC Marketing Team) (Taken out of order)

Prince George's County Planning Board Public Affairs and Marketing Officer Andrea Davey introduced the M-NCPPC Internal Marketing Team (members listed on page 1 of minutes). She also introduced LMD Marketing Consultants Scott Van Der Meid, Mary Ellen McCormack, and Kristen Newton. Ms. Davey explained that the Internal Marketing Team has been working with LMD to implement focus groups in both

counties to help identify branding strategies that would be best received by our customers. Input from the focus groups was shared with Department Directors and is now being shared with the Executive Committee. The purpose of the presentation was to obtain support to move forward with the creative design portion of the branding study. Ms. Davey shared that Commissioner Amy Presley joined the team to assist with her marketing expertise.

LMD Consultants presented a PowerPoint briefing titled, "Phase 1 Research Focus Group Report". A copy was provided in the Executive Committee packet.

LMD Consultants McCormack and Newton shared that the focus groups were held in both Montgomery and Prince George's Counties. The presentation reviewed a number of findings.

Ms. Newton shared that the focus group:

- Was not in favor of retaining the current logo.
- Supported using a name different than M-NCPPC when referring to the agency. Also concerns were expressed about changing the name fully from M-NCPPC due to legal implications. General Counsel Gardner had discussed challenges pertaining to the State Code and that M-NCPPC may need to be retained legally, but an alternative name could be used operationally.
- Agreed that M-NCPPC delivers important services, programs and important benefits. On the Montgomery County Planning side, the focus group identified with the need for smart and controlled planning. On the Prince George's side, the focus group related more to the community services/ activities.
- Expressed trust in M-NCPPC to do the job and represent the interest of the community on the planning side. They agreed that M-NCPPC should spread the word about itself because of the valuable benefits it provides.
- Responded that the current websites are difficult to use.

LMD Consultant, Van Der Meid discussed ideas for the creative piece on brand identity. He shared the challenge in the branding aspect of developing the logo. Executive Director Barney mentioned that Prince George's County Planning Director Fern Piret made a recommendation to use "Maryland Park and Planning" to achieve a broader context of park and planning; and as it is chartered by the State of Maryland and not a county agency. In discussing the key findings, Chair Hewlett agreed that the current websites need work; the current mission statement may need to be shortened for branding purposes; that M-NCPPC needs to be more proactive about telling its story; and the agency should work harder to address the unfavorable comments which were shared by the focus group.

Vice-Chair Anderson commented that the organization needs to determine how to market the planning side to encourage a positive perception of the planning function and to calibrate the public's expectations as to what planning encompasses.

Montgomery County Parks Director Mike Riley inquired whether the Internal Marketing team could write up a summary reminding Directors of the goals or the reason for the project. He would like to have something so he is able to respond to inquiries on the branding initiative. The Executive Committee thanked the team and shared that it looks forward to Phase 2 Creative Development.

Andrea Rose presented the Administrator's Report dated October 27, 2014. The Comprehensive Annual Financial Report (CAFR) was submitted to the Government Finance Officers Association for consideration of a Certificate of Achievement for Excellence in Financial Reporting. Sheila Joynes was recognized for her lead role in preparation of the CAFR, especially with implementation of the new GASB 67 statement. In an effort to "Go Green", the Annual Report which is a summary of the CAFR will be available online. Annual Statements will be mailed to members in mid-November. The Investment Monitoring Group meeting on November 18, 2014 will begin at 9:00 a.m.

MS. ROSE presented the regular report for the Investment Monitoring Group's (IMG) meeting of October 21, 2014. The IMG met with State Street Global Advisors' Rob Guiliano, Vice President and Senior Portfolio Manager, and James Thorsen, CFA, Vice President and Senior Relationship Manager for a performance review. The ERS' custom real assets strategy is passively managed and totaled \$88.1 million as of September 30, 2014. Net returns since inception (January 2013) were -2.28% vs. the Custom Index return of -8.84%. Real assets perform particularly well during a rising rate environment; are not as strong in a stable rate environment; and give up a bit in a declining rate environment. Recent underperformance can be attributed to fees and the cost of swaps/futures in the commodities index. The ERS is invested in real assets as an inflation hedge and for the diversification benefit. Wilshire is expecting better performance if/when there is an uptick in inflation. SSgA is holding more assets than targeted, but this is a parking place for funds for the private opportunities. Wilshire encouraged IMG members to be patient to see the benefit of this strategy. Real assets play a strategic role and match the ERS' risk tolerance and long-term horizon.

The IMG and Administration & Personnel Oversight Committees will meet bimonthly in 2015.

### B. Audit Committee

Presentation by Committee Chairman, Barbara Walsh

i. Regular Report of October 7, 2014

MS. WALSH presented the regular report for the Audit Committee's meeting of October 7, 2014. MS. WALSH reported CliftonLarsonAllen conducted a full scope audit for the fiscal year ended June 30, 2014 and issued an unmodified "clean" opinion on the ERS' financial statements. There were significant changes to the investment and actuarial disclosures due to implementation of GASB 67. There were no material weaknesses or significant deficiencies identified. The significant increase in

Net Position from \$693,968,157 as of June 30, 2013 to \$796,135,587 as of June 30, 2014 was primarily due to a net investment gain of \$107,897,795.

### 6. PLAN AMENDMENTS

Presentation by LaTonya Reynolds, Associate General Counsel

- A. Recommendation to Adopt Plan Restatement Effective January 1, 2015, Except As Specifically Provided with Section 7.5 Marital Status as Required by IRS Guidance
  - i. Office of the General Counsel Memo dated October 27, 2014
     Re: Plan Document Amendments

MS. REYNOLDS discussed the Plan Document changes outlined in the Office of General Counsel Memo dated October 27, 2014 Re: Plan Document Amendments,

The amended language in Sections C-7.1 Employee Contributions and D-7.1 Employee Contributions increases the employee contributions by 0.5% effective March 1, 2015 and another 0.5% effective January 1, 2016 as previously approved by Commission Resolution No. 14-20.

The revision in Section 7.5 Marital Status clarifies that effective June 26, 2013 the ERS recognized Revenue Ruling 2013-17 in which the IRS held that the term spouse for all Federal tax purposes includes individuals, regardless of sex, who have entered into a legal marriage under the laws of the state or foreign country where the ceremony was performed.

MS. REYNOLDS recommended the Board adopt the attached Plan Document Restatement effective January 1, 2015, except as specifically provided with Section 7.5 Marital Status as required by IRS guidance.

DR. BUCHER made a motion, seconded by MS. GOGOL to adopt the attached Plan Document Restatement effective January 1, 2015, except as specifically provided with Section 7.5 Marital Status as required by IRS guidance. The motion PASSED unanimously (8-0). (Motion #14-51)

### 7. Manager Reports/Presentations

Presentation by Boomershine Consulting Group's David S. Boomershine, Senior Consulting Actuary and President; Gregory M. Stump, Vice President and Senior Actuary; and Sunita Bhatia, Senior Consultant and Actuary

A. Recommendation to Approve an Employer Contribution of \$27,191,305 Payable July 1, 2015

Gregory M. Stump conducted a Trustee Education Session titled *Actuary 101* covering the key elements and primary outputs of a valuation, actuarial assumption setting, and the Governmental Accounting Standards Board.

Sunita Bhatia reviewed the results of the July 1, 2014 Actuarial Valuation which indicated the funded ratio of the actuarial value of assets to the actuarial accrued liability for benefits was 87.2%, which is up from 83.1% in 2013. As of July 1, 2014, the actuarial value of assets was \$766,531,514 and the actuarial accrued liability was \$879,190,389, which resulted in an unfunded actuarial accrued liability of \$112,658,875.

Dave Boomershine noted the July 1, 2014 actuarial valuation included an investment return assumption of 7.3% (down from 7.4%) and salary assumption of 2.8% (down from 2.9%) per year plus additional merit increases. An Experience Study will be conducted after the July 1, 2015 actuarial valuation with results presented in early 2016. The July 1, 2014 actuarial valuation also recognized employee contribution changes in Plans A and B. The recommended employer contribution decreased from 21.8% to 20.1% of payroll primarily due to a gain on the actuarial asset value. The recommended contribution payable July 1, 2015 is \$27,191,305 (20.1% of payroll).

DR. BUCHER made a motion, seconded by MS. GOGOL to approve an employer contribution of \$27,191,305 (20.1% of payroll) payable July 1, 2015. The motion PASSED unanimously (8-0). (Motion #14-52)

Dave Boomershine recommended the Board reduce the investment return assumption from 7.3% to 7.25% for the July 1, 2015 actuarial valuation. The Board agreed to consider this recommendation in early spring with Boomershine Consulting Group and Wilshire Associates.

Ms. Rose recognized Tonia Lanier, Member Relations Manager, Lisa Butler, Senior Retirement Benefits Analyst, and Ann McCosby, IT Manager, for their respective roles and efforts in submission of the actuarial data to Boomershine Consulting Group. Mr. Boomershine complimented staff on the thoroughness of the data.

The Board of Trustees meeting of November 4, 2014 adjourned at 11:30 a.m.


